Definitions of special educational needs (SEN) taken from section 20 of the Children and Families Act 2014.

A child or young person has SEN if they have a learning difficulty or disability which calls for special educational provision to be made for them. A child of compulsory school age or a young person has a learning difficulty if they:

- a) Have a significantly greater difficulty in learning that the majority of the others of the same age; or
- b) Have a disability which prevents or hinders them from making use of educational facilities of a kind generally provided for others of the same age in mainstream schools or mainstream post -16

A child under compulsory school age has special educational needs if they fall within the definition at (a) or (b) above or would do so if special educational provision was not made for them.

*Children must not and will not be regarding as having learning difficulties solely because the language or form of language of their home is different from the language in which they will be taught.

New legislation (The Children and Families Act 2014) came into force from the 1st September 2014. A new SEN code of practice also accompanied this legislation.

One significant change arising from the reforms is that statements of Special Educational Needs, for those children with the most complex needs, have now been replaced with a new Education, Health and Care (EHC) Plan. This information is also available by putting the above web address into the browser of a smart phone or tablet.

The SEND Local Offer is a resource which is designed to support children and young people with special educational needs and/or disabilities and their families. It describes the service and provision that are available both to those families in Hull that have an Education, Health and Care Plan and those who do not have a plan, but still experience some form of special educational need. The SEND Local Offer includes information about public services across education, health and social care, as well as those provided by the private, voluntary and community sector.

At Griffin Primary School we are proud to provide a safe, stimulating and inclusive learning environment where every member of our community is valued and respected.

Our broad, balanced, creative curriculum and enrichment activities provide opportunities for everyone to achieve and succeed to the best of their ability.

Together we take pride in making a positive contribution to our school and the wider community.

1. Aims and objectives

Aims

We aim to provide every child with access to a broad and balanced education. This includes the National Curriculum in line with the *Special Educational Needs Code of Practice*.

Objectives

- Staff members seek to identify the needs of pupils with SEN as early as possible. This is done most effectively by gathering as much information as possible from parents, education, health and care services and previous settings prior to the child's entry into the school.
- Monitor the progress of all pupils in order to aid the identification of pupils with SEN. Continuous monitoring of those pupils with SEN by their teachers will help to ensure that they are able to reach their full potential.
- Make appropriate provision to overcome all barriers to learning and ensure pupils with SEN have full
 access to the Curriculum. This will be co-ordinated by the SENCo and Head of School and will be carefully
 monitored and regularly reviewed by the senior leadership team in order to ensure individual targets are
 being met and all pupils' needs are catered for.
- Working with parents to gain a better understanding of their child, and involve them in all stages of their child's education. This includes supporting them in terms of understanding SEN procedures and practices and providing regular feedback on their child's progress.
- Work with and in support of outside agencies when the pupils' needs cannot be met by the school alone.
 Some of these services include Educational Psychology Service, Speech and Language Therapy, Children and Adult Mental Health Services CAMHS, Northcott Outreach, IPaSS and Whitehouse Outreach.
- Create a school environment where pupils can contribute to their own learning. This means encouraging relationships with adults in school where pupils feel safe to voice their opinions of their own needs, and

carefully monitoring the progress of all pupils at regular intervals. Pupil participation is actively encouraged through school by wider opportunities such as school council, residentials, educational visits, class assembles, clubs and sports teams.

1. Responsibility for the coordination of SEN provision

- The person responsible for overseeing the provision for children with SEN is Mrs J Garmston (Head of School)
- The person co-ordinating the day to day provision of education for pupils with SEN is Mrs L Walker (SENCo)
- The Designated Person for safeguarding is Miss S Carr (Assistant Head Teacher)
- The Governing Body are responsible for the effective use of Pupil Premium funding

2. Arrangements for coordinating SEN provision

The SENCO will be responsible for holding and updating all SEN records securely for individual pupils.

Staff can access:

- The Griffin Primary School SEN Policy
- A copy of the full SEN Register.
- A pupil's individual confidential SEN file (with the consent of the Head of School of the SENCo)
- Guidance on or a copy of The SEN in the Code of Practice
- Information on individual pupils' special educational needs, including the pupil class files which contain their pupil passport, Individual Learning Plan and any other relevant medical information
- Practical advice, teaching strategies, and information about types of special educational needs and disabilities.
- Information is also available through Hull's SEND Local Offer
- The pupil's Pupil Passport

This ensures that every staff member will have up-to-date information about pupils with special needs and their requirements which will enable them to provide for the individual needs of all pupils.

This policy is made accessible to all staff and parents in order to aid the effective coordination of the school's SEN provision.

3. Admission arrangements

Please refer to the information contained in our school admission policy.

The admission arrangements for all pupils are in accordance with national legislation, including the Equality Act 2010. This includes children with any level of SEN; those with Education, Health and Care Plans and those without.

4. Specialist SEN provision

We are committed to whole school inclusion. In our school we support children with a range of special educational needs. We will seek always seek specialist SEN support from other professionals if required and will seek training from SEN services where necessary.

5. Facilities for pupils with SEN

The school complies with all relevant accessibility requirements; please see the school accessibility plan for more details.

6. Allocation of resources for pupils with SEN

All pupils with SEND will have access to element 1 and 2 of a school's budget which equates to £6,000. Some pupils with SEND may access additional funding. This additional funding might be from a budget which is devolved to and moderated by the Family of Schools. (The Family of Schools comprises of a secondary school and its feeder primary schools). For those with the most complex needs, additional funding (High level needs HLN) is retained by local authority. This is accessed through the family of schools. The family SENCO will refer individual applications to a multi-agency panel, which is administered by the local authority, who will determine whether the level and complexity of need meets the threshold for this funding. It would then be the responsibility of the SENCO, senior leadership team and governors to agree how the allocation of resources is used.

7. Identification of pupils needs

Identification - See definition of special educational needs at start of policy

A graduated approach:

Quality first teaching

- a) Any pupils who are working significantly below (1 year or more) the expected standard for their age will be placed on the SEN register for learning and will be given a pupil passport and Individual Learning Plan.
- b) Once a pupil has been identified as having a SEN they will be monitored by staff in order to gage their level of learning and to identify any specific difficulties.
- c) The child's class teacher will take steps to ensure they provide differentiated learning opportunities that will aid the pupil's academic progression and enable the teacher to better understand the provision and teaching style that needs to be applied. The teacher will plan for a pupil with learning needs by using the STEPS.
- d) The child will have an individual learning plan with specific targets to be worked on by the child with the support of the class teacher and teaching assistant
- e) Any pupil working significantly below standard will be placed on the SEN "STEPS" which will ensure they are able to work in the same way as their peers but using smaller and more manageable learning objectives

- f) The SENCO will be consulted as needed for support and advice and the pupil will be then observed at regular intervals
- g) Parents will be kept informed by the class teacher regarding their child's development and the circumstances under which they are being monitored. Parents are encouraged to share information and knowledge with the school.
- h) Any concerns regarding a child's progress will be discussed by the teacher during parent's evenings or via telephone or in person by the SENCo.

SEN Support

Where it is determined that a pupil has SEN needs, parents will receive a copy of the child's Pupil Passport and the pupil will then be added to the SEN register. The aim of formally identifying a pupil with SEND is to help school ensure that effective provision is put in place and so remove barriers to learning. The support provided consists of a four part process:

- Assess
- Plan
- Do
- Review

This is an ongoing cycle to enable the provision to be refined and revised as the understanding of the needs of the pupils grows. This cycle enables the identification of those interventions which are the most effective in supporting the pupil to achieve good progress and outcomes.

Assess

This involves clearly analysing the pupil's needs using the class teacher's assessment and experience of working with the pupil, details of previous progress and attainment, comparisons with peers as well as the views and experience of parents. The pupil's views and where relevant, advice or reports from external support services will also be considered. Any parental concerns will be noted and compared with the school's information and data on how the pupil is progressing.

This analysis will require reviews to ensure that support and any intervention put in place is matched to the need, that barriers to learning are clearly identified and being overcome and that the interventions that may be being used are developing as required. Where external support is already involved their work will help inform assessment of need. Where they are not involved they may be contacted, if this is felt to be appropriate, following agreement from parents.

Plan

Planning will involve consultation between the teacher, SENCO and SEN teaching assistants to agree the adjustments, interventions and support that is required; the progress that is expected and a this will be regularly reviewed. This will be recorded on the child's Pupil passport and individual learning plan which are used to inform staff and parents. Parental involvement may be sought, where appropriate, to reinforce or contribute to progress

at home and the pupil passport will indicate what parents can do at home to support their child. All those working with the pupil, including support staff will be informed of their individual needs, the support that is being provided, any particular teaching strategies/approaches that are being employed and the outcomes that are being sought.

Do

The class teacher remains responsible for working with the child on a day-to-day basis. They will retain responsibility for the progress the child makes even where the interventions may involve group or one-to-one teaching away from the main class teacher. They will work closely with teaching assistants and to plan and assess the impact of support and intervention and links with classroom teaching. Support with further assessment of the pupil, agency involvement and advising of the implementation of effective support will be provided by the SENCO.

Review

Progress is assessed as part of the planning of day-to-day provision. Formal reviews of a child's progress will be made at least termly. The review will evaluate the impact and quality of the support and interventions. It will also take account of the views of the pupil and if necessary their parents. The class teacher, with the support of the SENCo will revise the support based on the pupil's progress and development making any necessary amendments going forward, consulting with the pupil where necessary.

Referral for an Education, Health and Care Plan

If a child has lifelong or significant difficulties that effects their education they may undergo a statutory assessment process which is usually requested by the school but can be requested by a parent. This will occur where the complexity of need or a lack of clarity around the needs of the child are such that a multi-agency approach to assessing that need, to planning provision and identifying resources, is required.

The decision to make a referral for an Education, Health and Care Plan will be made after the school and any other agencies involved agree that this is the best course of action for the pupil.

The application for an Education, Health and Care Plans will combine information from a variety of sources including:

- Parents
- Teachers
- SENCo
- Social Care
- Health professionals

Information will be gathered relating to the current provision provided and an application and supporting evidence will be submitted by the SENCo. A decision will be made by a panel made up of professionals from education, health and social care about whether or the child is eligible for an EHC Plan. Parents have the right

to appeal against a decision not to initiate a statutory assessment leading to an EHC Plan. The school are not responsible for the decision as to whether to issue an EHCP.

- a) Following statutory Assessment, an EHC Plan will be provided by the local authority, if it is decided that the child's needs are not being met by the support that is ordinarily available. The school and the child's parents will be involved developing and producing the plan.
- b) Parents have the right to appeal against the content of the EHC Plan. They may also appeal against the school named in the plan is it differs from their preferred choice.
- c) Once the EHC Plan has been completed and agreed, it will be kept as part of the pupil's formal record and reviewed at least annually by staff, parents and the pupil. The annual review enables provision for the pupil to be evaluated and, where appropriated, for changes to be put in place, for example, reducing or increasing levels of support.

7. Access to the curriculum, information and associated services

Pupils with SEN will be given access to the curriculum through the specialist SEN Provision provided by the school as is necessary, as far as possible, taking into account the wishes of their parents and the needs of the individual.

Every effort will be made to educate pupils with SEN alongside their peers in a mainstream classroom setting. Where this is not possible, the SENCo will consult with the child's parents for other flexible arrangements to be made.

Regular training and learning opportunities for staff on the subject of SEN and SEN teaching are provided in school and across the local network. Staff members are kept up to date by the SENCo and SLT with strategies and sources of support which may help support the progress of pupils with SEN.

In class provision and support are deployed effectively by class teachers to ensure the curriculum is differentiated as necessary. We make sure that individual or group intervention is available where it is felt pupils would benefit from this.

We set appropriate individual targets that motivate pupils to do their best, and celebrate achievements at all levels.

8. Inclusion of Pupils with SEN

The Head of School and SENCO oversee the school's policy for inclusion and are responsible for ensuring that it is implemented effectively throughout the school.

The school curriculum is regularly reviewed to ensure that it promotes the inclusion of all pupils. This includes learning outside the classroom.

The school will seek advice, as appropriate, around individual pupils, from a range of external support services.

Advice may be sought from Whitehouse Outreach for the children who have behavioural concerns.

Griffin Primary School recognises that children at school with medical conditions should be properly supported to ensure full access to the curriculum. Please refer to the school's Medical Policy.

9. Evaluating the success of provision

In order to make consistent continuous progress in relation to SEND provision the school encourages feedback from staff parents and pupil throughout the year.

Pupil progress will be monitored on at least a termly basis. All pupils working significantly below standard are now using the STEPS which are useful in helping staff evaluate pupil progress as well as planning appropriate provision.

SEN provision and any interventions for pupils are recorded on their pupil passports and these are updated regularly. These are updated by the class teacher and are monitored by the SENCO and SEN assistants. These reflect information passed on by the SENCO and the previous teacher at the beginning of an academic year and are adapted as required.

10. Complaints procedure

If a parent or carer has any concerns or complaints regarding the care or welfare of their child, the process within the school will be followed. This process supports resolution of any concern or complaint. If resolution is not reached then parents or carers will be signposted to the school complaint procedures.

11. Continuous Professional Development

We aim to keep all school staff up to date with relevant training and developments in teaching practice in relation to the needs of the pupils within SEN.

The SENCo attends relevant SEN courses, local SENCo meetings and may facilitate or signpost relevant SEN focused external training opportunities for all staff via the SLT.

We recognise the need to train all our staff on SEN issues and we have funding available to support this professional development. The SENCO, along with the rest of the senior leadership team, ensures that training opportunities are matched to school development priorities and those identified through the use of provision and those identified through the use of provision management (See section 11).

12. Links to support services

The school continues to build strong working relationships and links with external support services in order to fully support our SEN pupils and aid school inclusion.

Sharing knowledge and information with our support services is key to the effective and successful SEN provision within our school. Any one of the support services may raise concerns about a pupil. This will then be brought to the attention of the SENCO who will then inform the child's parents.

13. Working in partnership with parents

Griffin Primary School believes that a close working relationship with parents/carers is vital in order to ensure

- a) Early and accurate identification and assessment of SEN leading to appropriate referrals, intervention and provision
- b) Continuing social and academic progress of children with SEN in line with their capabilities
- c) Personal and academic targets are met effectively

In cases where more frequent regular contact with parents is necessary, this will be arranged based on the individual pupil's needs. The SENCo may also signpost parents of pupils with SEN to the appropriate external service where specific advice, guidance and support may be required. It is the parent's choice whether they choose the act upon advice or recommendations given by the school.

14. Bullying and Discrimination

Griffin Primary School works towards a positive and safe environment for all children. Refer to the school's Anti bullying policy. The school works towards Emotional Wellbeing and gives the children opportunities to have their voices heard through:

- Jigsaw
- Circle time
- Working with the EWB Staff
- School Council

15. Links with other schools

The school works in partnership with other schools in the academy and with schools across the city. This enables the schools to build a bank of joint resources and to share advice, training and development activities and expertise. The SENCo attends regular SENCo cluster meetings to share practice and resources.

16. Links with other agencies and voluntary organisations

Griffin Primary School invites and seeks advice and support from external agencies in the identification and assessment of, and provision for, SEN. The SENCO is the designated person responsible for liaising with the following:

- City Education Psychology Service
- Whitehouse Outreach
- Speech and Language Service

- Northcott Outreach
- School Nursing Team
- CAMHS
- IPaSS (physical and sensory support)
- Occupational Therapy

In cases where a child is under observation or a cause for concern, focused meetings may be arranged with the appropriate agency.
